DIS4SME Survey

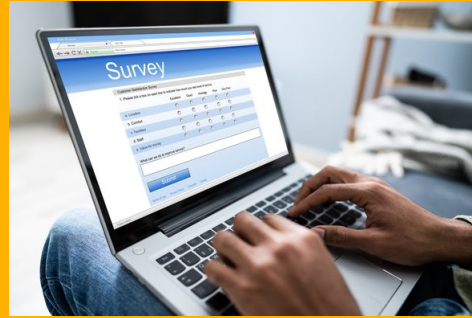
Location data interoperability is the ability of organisations, systems and devices to exchange and reuse data with direct or indirect reference to a specific location or geographical area.

DIS4SME will design and deliver **short-term training courses** for upskilling and reskilling of the labour force, with a particular focus on **SMEs owners, managers and employees**.

The courses will offer content that is suited to the current and future needs of SMEs in the form of **baseline knowledge, state-of-the-art technology, and policy trends**.

The courses will be available next year and they will be designed based on co-creation and collaboration between:

- SMEs business leaders and managers, employees and job searchers;
- European Digital Innovation Hubs;
- Business Associations;
- Public Administrations; and
- Training providers.

DIS4SME will deliver three types of courses (on-line and in presence):

- Short - term courses (max 2 days) for SME owners and managers
- Short - term courses (max 2 days) for SME employees and job seekers
- Intensive seminars and workshops (max 1 day) focused on Business Cases
